MAHSLIN Web Site Report

MAHSLIN Resource Sharing Report

MAHSLIN's StatRef group purchase entered its seventh successful year in 2012. Although we lost a few participants due to hospital library closures, we were able to continue with twenty-two libraries included in our group. This resource has been a very cost-effective way for many of our smaller hospital libraries to be able to provide an extensive e-book collection and also a way for our larger institutions to provide additional access to their e-books. This year some of the libraries have voiced concerns on low usage of e-books by their staff, and have asked for suggestions on how to promote their e-book collections.

MASHLIN members can also take advantage of a significant reduction in the annual fee for the R2 e-book platform. MAHSLIN members pay only a \$400 annual fee versus the usual \$1200 fee. R2 collections are purchased for the life of the edition so you can use your e-book budget to add to your list of titles and build a collection that you will continue to own.

The Massachusetts Library System (MLS) is also interested in working with our members to determine what special services are needed by the healthcare library community. In December, 16 health science librarians met with MLS staff to discuss issues of common concern. Our members suggested that they would be willing to work more closely with public libraries when

clinical information is needed. The group thanked the MLS for making the Gale databases available, but also indicated that it would be helpful if the MLS could work with us to provide discounts to other resources, particularly CINAHL. Our members noted that the mediated ILL service through the regional centers and the BPL helped us provide resources outside the health science field. Continuing education, particularly through Webinars, was also discussed with the possibility of our members teaching some classes on health science resources. The Board will continue to investigate ways in which shared resources could benefit our members. We welcome your comments and suggestions.
