Over the past year the Publicity Committee discussed and planned a new web design.

The goal of the redesign was to retain the best features of the current site, while adopting a more contemporary look with multi-functionality. We also improved specific sections

of the site such as the Events Calendar, the Newsletter. The Membership directory has recently been updated. The MAHSLIN Procedures Manual was also included in the Bylaws section.

Resource Sharing

Over the years there has been some interest expressed in MAHSLIN pursuing group purchasing options for our members. At last spring's RLM Resource sharing day, we heard how other states have gone about setting up state-wide resource sharing. The Board felt that perhaps it was time to once again assess the interest of our members. Last fall, I initiated a survey of the entire membership to see if this interest still existed and how many of our members would like to participate in group purchasing.

The survey was twofold. One section asked what specific electronic resources people currently had, and the second part asked what resources they would like to add. The first part would allow us to see if there might be a way to collectively negotiate better pricing with a vendor. The second part would give us an indication of which resources our members needed but didn't currently have.

Thirty-seven (37) libraries responded to the survey. The top four electronic resources that members currently have are: UpToDate, CINAHL, Cochrane, and StatRef. The 2nd part of the survey listed StatRef, Doody's, Cochrane, and UpToDate as resources libraries would like to have. We found out that UpToDate is not interested in negotiating on a statewide level. StatRef is willing to set up a group purchase, and has implemented

this on a statewide level with the state of Michigan. One obstacle to a group purchase of StatRef is that individual billing is not available, and a system would have to be implemented to invoice and collect payments for the group. The SEMCO consortium is currently implementing a group purchase with StatRef. The MAHSLIN Board has decided to see how this works with a smaller group and look at the possibility of extending this on a statewide level in the future. I have also been in contact with a representative from Wiley InterScience about a group purchase to the Cochrane database, and will continue our conversation.

Group purchasing is further complicated by fact that some libraries already have subscriptions to these resources with various expiration dates, and other libraries have been able to set up group discounts through their healthcare systems. However, since we now know that there are still some of our members who cannot afford to purchase access to resources they would like to have, we will continue to explore the possibility of group purchasing for MAHSLIN members.
