


#### TechnoTool Corner





Imagine that you are browsing the internet and see something that you wish you could just right click and research it in Ovid from the contextual menu that comes up. Well, you can!




Here are the steps to setup FIREFOX to do just that:

- 1. Go to: http://demo.ovid.com/demo/ovidsptools/browser\_search.htm
- 2. A list of options shows up and you can add as many resources as you wish to in the list to work as a search engine in Firefox assuming you subscribe to the resource.



- As you click on one of them, the system will bring up a dialog box for you to confirm that you wish to add the search engine.
- 4. Click the **ADD** button.



#### DO NOT CHECK THE BOX to make


it your default search engine though

because these only search in Ovid and you want to have it for default something like Google, Yahoo, or any other search engine that searches outside of Ovid.


## TWO WAYS TO USE AN OVID RESOURCE AS A SEARCH ENGINE

#### A. USING THE CONTEXTUAL MENU

 Select the resource that now shows as a search engine in the Firefox search engine on the top right of the browser.



2. **Highlight text** in any page on the web, **RIGHT CLICK**, and <u>click on the Ovid Search</u> <u>option</u> in the contextual menu:




#### **B. USING**

#### **KEYWORDS IN THE URL ADDRESS/SEARCH FIELD**

#### **FIREFOX**


 Select the resource that now shows as a search engine in the Firefox search engine on the top right of the browser.



 Enter a question or keywords in the search field left of the resource that you chose and hit ENTER.



Ovid will process a Basic Search with related words.



#### INTERNET EXPLORER

1. Write the question or keyword and then **Select the resource** that will show when you press the <u>magnifying glass icon on the right of the URL/Search field</u>



The search will be performed as soon as you click the Ovid Icon of the resource (Medline, Your Journals, whichever you added there and want to use. In IE you cannot use the highlight text feature but this kind of search works just the same as in Firefox.

#### **ADVANCED:**


From there you can apply a filter and change the Basic Search to an Advance search, go to the Advance tab and start combining options with Boolean operators if you wish.

When you are done, switch the default search engine back to your favorite such as Google, Yahoo, etc.


#### MANAGING YOUR SEARCH ENGINES

You may wish to "clean up" your list of search engines in Firefox now and then. To manage the list, follow these steps:

1. Open up the Search Engine menu and select Manage Search Engines



2. Select one of the resources and Move UP, Move Down, Remove, etc.
