#### Resource Sharing Annual Report 2017 : Jeanie Vander Pyl/ Chair

One of the benefits of being a MAHSLIN member is the opportunity to take advantage of savings realized through our Resource Sharing offerings.

MAHSLIN members can participate in the STATRef group purchase that is a very cost effective way to provide a core collection of e-books for your institution. MAHSLIN members can only become a part of this group purchase during the renewal process that is currently underway.

New and existing R2 e-books customers also receive a reduction in their annual maintenance fee if they are members of MAHSLIN. The annual fee is reduced to \$400. Unlike the group purchase through STATRef, members can choose their own titles, which they will "own" forever.

Another great resource for MAHSLIN members is access to a collection of e-books of interest to librarians in the health science field. You can view this collection on the MAHSLIN website under the "Resources" tab. To access the books, contact our webmaster to obtain the username and password. Each year, a few new titles are added to this collection. Three new titles were added this past year: "The Accidental Data Scientist," "Balancing Copyright in the Digital Age," and "The Top Technologies Every Librarian Should Know." The collection now contains 24 books with insights for providing new services and maintaining relevancy in the digital era.

This will be the last year that I will be serving as your Resource Sharing Chair. When I was originally asked to take on this role in 2004, the main task was collecting and compiling the annual inter-library loan statistics for all MAHSLIN member libraries. This task was discontinued in 2006, as fewer libraries submitted their statistics and it was felt that the data was no longer meaningful or useful. After surveying the membership on their preferences for resources and their interest in group purchases, the STATRef group was implemented in 2007. The annual task of determining which libraries would participate and then selecting a collection to fit within the available funds has become a lot easier each year.

This year I would encourage our hospital libraries, to register and explore the new partnership being formed between the HSLANJ group and the NER. The HSLANJ group licensing initiative will bring additional opportunities for New England hospitals to realize savings on purchasing resources.

The MAHSLIN LibGuide use has increased by 11% this year, for a total of 4400 total page views between 4/1/2016 and 3/31/2017. The home page, 2017 Annual Meeting Page, Membership and 2016 Annual Meeting page logged the highest visits.
