Annual Resource Sharing Report – 2008-09 Jeanie Vander Pyl Resource Sharing Chair MAHSLIN

MAHSLIN's StatRef group purchase entered its third successful year. We added two new libraries to the group and made title changes to our collection by consensus of the group. We were able to add 7 new titles and dropped 4 which had low usage. The renewal process of this valuable and cost-effective resource is currently in progress. Although we know we will lose a few hospitals due to library closings, we're hoping others might join who can't maintain all their current print resources due to reduced budgets. The MAHSLIN StatRef program is a very cost-effective way to maintain a current collection to the top resources in medicine and nursing.

The membership was querried during the summer about adding AORN Perioperative Standards to the STATRef resources. Unfortunately, interest was not sufficient to add this resource.

An online survey of members was also conducted during the summer and fall. The Board has begun to review the results to determine what resources our members are using or would like to have. Knowing what our libraries are currently purchasing on their own enables us to work with vendors to offer discounts to our group. The survey also asked for people who would like to serve on the Resource Sharing Committee. Those who volunteered will be contacted in the near future as we look to setting up additional products.

Consortium pricing to LibGuides was also offered to MAHSLIN members who were looking for an easier way to set-up and maintain dynamic webpages.

We will continue to investigate ways in which shared resources could benefit our members. We welcome your comments and suggestions.

We may see more membership dues in before the annual meeting. After the meeting, I will send a separate reminder email only to those who have not renewed.

I have implemented a new system for the online membership directory. At the end of each month, a list of all new or renewed members is sent to the webmaster, who updates the directory with changes in information. At that time, the webmaster also notes the last year their dues were paid. When a member's last dues were paid more than 2 years ago, they are sent a reminder about renewal and the benefits of MAHSLIN membership, and if they do not renew, they are removed from the online directory.

There are several benefits of this system:

- Members can see whether they need to renew their membership by looking at the "dues last paid" year.
- Organizers of meetings can see whether their registrants have paid the current year's MAHSLIN dues.

- The online directory stays up to date with members' current contact information and with a list members currently involved.
- The Membership Chair does not need to send out emails to each member indicating that their dues were received (though if there is question, members can certainly inquire).

At the most recent board meeting, I proposed that we consider offering an online payment option for dues. Board members agree agreed that I should move ahead with this plan, and allow for online payment for MAHSLIN events as well. I will work with the webmaster to accomplish this before January 2010.
